World Archery Americas will hold a Continental Judges' Seminar in Orlando, Florida, on November 8-10, 2019. This seminar will be run by International Judges Sergio FONT (Chairman of World Archery Americas Judges' Committee) and Robert PIAN. All sessions will be conducted in English only.

Only judges who have been National Judges for at least two years can take the written test at the end of the seminar. Sit-ins are welcome. Registration forms must be emailed to worldarcheryamericas@gmail.com by September 7, 2019. (Form is attached).

Lodging: The seminar will be conducted at the Courtyard by Marriott Lake Buena Vista at Vista Centre Hotel in Orlando. An information sheet on the hotel and room prices is attached. The hotel fee includes breakfast for one person in each room. There is a 7.00 USD charge per day to cover breakfast for each additional person in each room. This amount will be added to the room rate at reservation and/or check in. Lunch and dinner are not included in the hotel room rate.

Accommodation payment must be made directly to the hotel. **Once you have registered**, we will provide you with a link to reserve and pay. The hotel has requested that payment should be made at least 30 days prior to the event days: (October 7).

Seminar Registration Fee: 100.00 USD – to be paid cash USD on the first day of the seminar.

Airport and ground transport: The host provides airport (Orlando International Airport) to hotel ground transport on Thursday Nov. 7, and to the airport on Nov. 10 (night) and Nov. 11. Flight schedules should be informed to Sergio FONT at worldarcheryamericas@gmail.com by October 30.
