JOAD FORMAT:

Recurve Bow - Juniors and Cadets - Cub and Bowman -	60 arrows from 18 meters; 40 cm target face (choice of single-spot or vertical 3-spot face from 18 meters — must use choice for entire tournament); outer 10 ring; 60 cm target face; outer 10 ring
Compound Bow- Juniors and Cadet -	60 arrows from 18 meters; 40 cm target face (choice of single spot or vertical 3-spot face from 18 meters — must use choice for entire tournament); use inner 10 ring;
Cub and Bowman -	40 cm target face (choice of single-spot or triple-spot face from 18 meters — must use choice for entire tournament); use outer 10 ring

NAA Dress Code will be enforced...this includes official practice sessions <u>USA Archery - Rules & Regulations - Dress Code</u>

Requirements:
